mously approved this recommendation made by the Finance Committee. We are on our intended course to pay off the debt for our land acquisition in seven years. We will continue to improve our race management and racing schedule (more about this in a minute). And we're going to fix stuff that's broken or at least not quite what it should be for our quality sailing program.

The Five Key Objectives for FBYC developed by Jay remain substantially unchanged for 2006. We will continue to closely manage our operations and spending, we will complete our Long Range Plan after conducting a comprehensive member survey this winter, we will monitor and tightly manage our capital spending, the new land will be made more useful and beautiful, and we will intensely focus on ways to improve sailing participation (in November, for example, two FBYC representatives attended a US Sailing session in Annapolis to help us improve participation).

My goals for 2006 are quite simple: all programs and facilities at FBYC should be stable, capable, and reliable. Those of you familiar with Quality programs recognize these objectives and in fact I bet every one of you who has prepared your boat for a race or cruise has sought the same in your vessel. What does it mean for FBYC?

• Stability - routines and checklists have been under development by many of your committees responsible for everything from chase boat preparation to personnel reviews to annual awards. With a volunteer rotating Board and daily changes in event management staff, "stable don't come easy" but we've already made good progress and we're going to keep doing better. When you step into a volunteer position the first thing you should do is ask for someone else's checklist, then improve it and pass it on.

- Capable staffing is a tremendous challenge in a volunteer organization but look at what's been accomplished and what's under way. Last year and already in planning for 2006 are training sessions for race committee management and piloting Mr. Roberts. We saw highly-capable Junior instructors launch our Club's junior program to a whole new level of fun and competitiveness, and we are aggressively seeking similar top-level instructors for next year. We have many repeat Board members this year combined with talented new members, so we can leverage the experience of those who've spent a year or two managing our assets while also bringing fresh skill sets to bear for FBYC. Every member has certain skills that can make substantial contribution to our Club, an incredible resource of capabilities.
- Reliability has sometimes been a challenge for our Club because we have been growing recently and have been financially challenged to attend to our legacy assets. Bulkheads will be repaired, we will add a new mark boat for better and safer race management, newly laid-out one-design parking on the new land (Continued on page 11)

HOUSE - John Koedel, Jr. advised that end-of-year touch-up painting and maintenance to the main clubhouse and to Fannie's House are underway. Dixon has replaced the porch screens.

good shape and has room for more boats. On October 31, the voting members of the Board were asked to vote by e-mail, in lieu of a special meeting of the Trustees, on a Resolution authorizing and directing the Flag Officers to proceed with contracting for the completion of Phase One of Jackson Creek Bulkhead Replacement on the terms outlined in the Proposal to Proceed with Phase One Bulkhead Replacement dated October 28, 2005. The Flag Officers unanimously endorsed and recommended the passage of the Resolution, which was passed by e-mail vote.

GROUNDS - Strother Scott advised that he would apply for a construction permit as soon as Bay Design completes the survey for the new road location. Lud Kimbrough reported that the two dead trees on the property would be taken down within a week or two.

LONG RANGE PLANNING -Strother Scott reported that they are still working on the survey to send to the membership.

FINANCE - Mason Chapman presented the 2006 Budget and stated that the Board would be asked to approve the Operating Budget. John Koedel moved that the 2006 Operating Budget be approved as presented; second by Strother Scott; motion passed.

WINTER PROGRAMS - Cam Hoggan has arranged for John Rousmaniere to speak at the February 10 winter program. The Bermuda High Party has a tentative date of March 3 and will be held at Strother Scott's home.

PUBLICITY - Izumi Miller sent out race results and other information about the fall races and regattas to various media outlets.

HISTORIAN - Jere Dennison reported that Mike Karn and Doug Magargee installed the new bookcase in the room that will become the Dan Austin Library. Jere could use more books. He is collecting pledges now.

OPERATIONS MANAGER -Allan Heyward and Ric Bauer conducted Dixon Cole's annual job review. Dixon did an excellent job during his first year and will be

CBYRA is updating their Bylaws and there will be a special meeting to discuss and approve them. The Annual General Meeting will be held the first weekend in December.

Highlights; Cont. from page 2) **OLD BUSINESS** – Ric Bauer moved that the Board approve a policy requiring that each member occupying a FBYC wet slip, drysail storage spot, parking or rack space in the small boat parking lot or a rack in the dinghy rack area sign a "Slip/Storage Lease Agreement" substantially in the form of, and containing the substantive terms set forth in the proposed lease circulated to the Board members prior to the meeting. Ric then opened the floor for discussion. Under the proposed policy and lease, members leasing slips on the Jackson Creek docks and parking spots in the keelboat drysail area, but not members leasing parking or rack space in the small boat parking lot and dinghy rack area, are required to provide the club evidence of insurance. All members storing boats at the club will be required to sign the lease each year. A separate form will be developed for use by transients. David Hazlehurst seconded the motion; motion passed.

NEW BUSINESS – Mayo Tabb and Ric Bauer are working on the electrical situation on the docks. Some owners have asked for 50-amp service. Mayo favors making it available to those who want it at a cost of \$250 per year, with the ability to easily convert back to 30-amp. Only the outer eight slips on the east and middle docks would be converted. Mayo will report back to the Board about this when more details have been worked out.

Eric Powers recommended that the club consider the purchase of an AED defibrillator. Lud advised that this is one of the safety issues Noel Clinard has been asked to look into.

The event, hosted by Fishing Bay Yacht Club, York River Yacht Club, and Stingray Harbor Marina, featured a variety of sailing and other boating activities for children, high-school students, and adults. Over 55 sponsors and more than 80 volunteers helped make the event so This year's July 8-9 successful. event weekend featured a special visit by the newly-constructed Schooner Virginia in addition to an auction at the Deltaville Fire Station, sailboat racing in both Offshore and Classic Yacht divisions, powerboat and kayak events, and a Junior Olympic Sailing Festival.

Event co-organizer Judy Buis recently attended a conference of Leukemia Cup organizers, where she was asked to speak to attendees about how the Southern Bay event has gotten to be so successful. "They were all curious as to how a small yacht club in a very small town could be so successful. By the end of my presentation, they all knew our success was due to the dedication of my great committee and the continued support and generosity of our sponsors and participants."

The event has made a great impact in working toward the Lymphoma and Leukemia Society's ultimate goal, to cure all blood related cancers. Buis wished to thank the members of FBYC, YRYC, Stingray Harbor Marina, and the surrounding communities for contributing so greatly to this event: "The survivors thank you, and the researchers thank you for giving them the opportunity to work on vital research."

California to Maine, staged Leukemia Cup regattas that fetched \$2.8 million and gave hope to the 712,000 Americans fighting leukemia, lymphoma and myeloma.

This year, the Virginia Maritime Heritage Foundation generously provided the Schooner Virginia for sightseeing during the event weekend, and many visitors to Virginia made financial contributions to the fundraising campaign of the Leukemia Cup event. An example of the community support the event received is the following story one organizer related: "We needed to ferry visitors to the Virginia, but we needed an inflatable to do so because you can't risk scratching her beautiful wooden hull. I called Tow Boat US Gwynn's Island, spoke to the owner about what we were doing, and he said, 'Sure, I'll be glad to bring my boat over and help. I'll get my partner to use my other boat if someone calls for a tow."

Next year's Leukemia Cup event will offer two days' of offshore sailing, which organizers hope will attract an even greater number of participants from throughout the Bay area. ©

Staggered Start

Last Saturday FBYC held its Closing Day Regatta. The conditions were excellent 15 - 20 Knot Northwesterly winds, a clear blue sky, and temperatures in the 50s. 19 boats had preregistered for the event and everybody showed up on the starting line except for Wrinkled Sheets, who merged their crew into Eric Power's Neried and Dick Cole's Nutcracker who withdrew out of concern and respect for Aaron Ryan Cramer, a long term crew member who tragically had a heart attack the day before and died at the age of 31. Many members knew him as he was a constant fixture around FBYC in recent years. His premature death cast a pall over the club that weekend.

The Closing Day Regatta is a staggered start race. This means that the slowest boats start first and are given a head start equal to their rating difference on the larger and faster To calculate the handicap boats. starting advantage requires advance knowledge as to the length of the course. I had a new system designed to allow any length course, but ultimately I decided on a windward starting leg, a 6-7 mile run down to L, just off Hole in the wall, a 6-7 mile beat back up to Stingray and a close reach into a finish off Stove Point - with a course length of 16 miles. That set the starting times, and our first starter, Pelican Cay was off at 11:05am.

Morningtide was the next starter, 18 minutes later. It was Russ Collins' first start since the ill-fated Wolf Trap race of September 20, 2004. He was followed by Desperado, in the non-spinnaker class and the rest of the B and Class A boat. The last boats the start were 4 J-105s who crossed the line about 39 minutes after the first boat.

There were some equipment failures and withdrawals. Chilcoot lost a halyard shackle before the race and was unable to start. David Clark's Corryvrecken's jib halyard broke on the long beat and they were forced to withdraw. Galileo withdraw when they decided to take a short cut home after a beautiful day on the water.

At the finish there were some surprises. Brad Davis and his J-105 Blade Runner took line honors. He left the other J-105s way behind and he was clearly way out in front. I do not recall the last time Brad got a first in fleet at FBYC. next finisher was Neried who was PHRF-A racing (with a spinnaker). It was not that long ago that Neried was usually in the non-spinnaker class. On this day, they started behind every boat except Wavelength, La Maga, and the J-105s, and they passed every one except Blade Runner. Great job by our Offshore Commander Eric Powers and his crew!

Wavelength was third, Loose Cannon was fourth, La Maga was fifth, and the sixth boat was the second to start. Morningtide had held off every one else and finished 6th overall and first in Class B. Russ, we need to see you out on the race course more often - your performance was outstanding - or maybe your daughter Caroline deserves the credit!

The second B boat was Shenanigan sailed by Miles Booth and one other person! That is not easily done.

Ric Bauer brought beautiful Desperado home as the first non-spinnaker boat.

After the last finisher, Pelican Cay radioed in that all was well, they were having a fine sail, and they granted us permission to head ashore and give out the trophies.

After the race, everybody thanked Kathy Clark, Brooks Zerkle, and me for setting a good course. Looking at their smiles, we could see that had all had a wonderful day siling at FBYC on the Closing Day Regatta. We agreed to return to run an even better course next October. ©

The Daniel Lee Austin Memorial Library

Progress toward the realization of the Daniel Austin Memorial Library in the main clubhouse took a major step in November with the installation of an African mahogany bookcase in the vacant office on the second floor. Created by Mike Karn and Doug Magargee, the bookcase will house books on sailing and other marine subjects donated by members. The core collection will consist of approximately one hundred volumes originally owned by Dan Austin and donated by the Family of Dan Austin in his memory. Other members are encouraged to contribute books as well.

The library is being entirely funded by Friends of Dan Austin that include both members and non-members. Carpet on the floor, furniture, new lighting, and a plaque on the door are also being planned with completion projected later this winter or early spring. When the library is fully operational, it will remain unlocked and be open to both visitors and members alike on an honor system basis. However, books may only be removed from the premises by members who must sign them out and return them within a reasonable time. Juniors will be required to have an adult member co-sign for them.

For individuals who wish to donate books, please contact me or leave them in the library. Write your name inside the cover of each book as we will affix a sticker inside of each identifying it as the property of FBYC and designating the donor's name. Books that will be acceptable for the library are limited to those with subjects of sailing, yacht design, cruising, racing, voyaging destinations, maritime history, marine ecology, seamanship, navigation, meteorology, boat maintenance, etc. Novels with serious nautical themes are welcome as well.

Books donated by the Family of Dan Austin and three other club members already occupy 20 - 25% of the available shelving. This leaves substantial space for additional donations. We plan to borrow one of the small square card tables and four chairs from the main area of the second floor until we can obtain the funds necessary to acquire a permanent table for the library. Since the room will continue to be used occasionally as a protest/meeting room for club events, it is important for us to equip it with furniture that will serve this dual purpose.

Some of our members may not have known Dan. He joined the club in 1972 having crewed aboard Andy Sinnickson's Hughes 38 Micheekeemoo and served on the Board in several capacities throughout the years. The sailing bug having bitten hard, he purchased a 505 that he actively campaigned around the region. In 1975, he sold his house in the west end of Richmond, put his furniture in storage, and, with his family of wife and two daughters, moved aboard a Pearson 35 where they spent a glorious winter-free year in the Bahamas. After his return to Richmond, he owned a series of racing boats, a Santana 20 and two J24's, all of which competed on a regular basis at FBYC. In 1985, having become enamored with the type of wooden shallowdraft sailing vessels designed and built by Commodore Ralph Monroe in southern Florida, he purchased a Presto 34 named Present Mirth. Dan and I moved his new boat from Kittery, Maine to FBYC in a memorable 17-day journey during the month of November which was made tolerable by a cheery cast iron wood burning stove below and a large stash of rum.

Although he intended to retire from racing and cruise *Present Mirth* on the shallow tributaries of Chesapeake Bay and North Carolina sounds, the competitive juices still flowed, and he continued to tweak his hull and rig for better performance. Bottom work, new sails, new aluminum mast, and a new air-foil shaped centerboard to replace the old wooden slab section combined to produce greater speed. In 1995, his boat finished second in a large fleet of traditional craft at the Turkey Shoot Regatta at Yankee Point Yacht Club then held over the



frigid Thanksgiving weekend. He was later featured prominently on the cover of Chesapeake Bay magazine aboard *Present Mirth* during this regatta, and a framed reproduction of this cover currently hangs upstairs in our clubhouse.

In 1997, he sold *Mirth* and purchased a J105 feeling that he had at least "one good sailing campaign" left in him. Besides club racing, he traveled with *Dark Star* to the NOOD Regatta in Annapolis and the Screwpile Regatta at Solomans Island. And he made frequent appearances with our cruising group on trips around the Bay. After selling *Dark Star*, he went kayaking in thin waters, crewed with others, and distinguished himself in club one-design events skippering Flying Scots loaned to him by other members. Tragically, Dan was stricken with pancreatic cancer and died in April, 2003. It is a tribute to his memory that so many sailing friends have so generously donated to the effort to create a library in his name at FBYC. \odot

They provided accommodations on the clubs 25 acre site for many of the sailors and provided a good meal and revelry Saturday night. Why Hold Invitational Events at FBYC?

This year FBYC held the usual Offshore, One-Design/Junior Spring Series, Summer Seabreeze and Fall Series, some drawing visitors from other clubs. A few other regular events, such as the Junior Regattas in June and August, Leukemia Cup in July, Annual One Design in August, Stingray in September, and Indian Summer in October drew more visitors, typically from regional clubs. These events are part of the standard racing fare at FBYC. In addition, FBYC periodically hosts other "invitational" regattas drawing larger numbers of visitors from distant clubs, often in association with class sailing associations, such as the Flying Scot or Laser associations. The latter events are the focus of this article.

During 2005, such invitationals included the Junior Olympics in July, the Chesapeake Bay Laser Masters in September, the Flying Scot Atlantic Coast and Capitol District Championships in September, and the J-29 Invitational in October. Back in 2004, we hosted the Optimist Atlantic Coasts, as well as the 2004 version of the Laser Masters, Flying Scot Districts and J-29 events.

Going forward, we have the opportunity to compete as the venue for other events. For example, FBYC has been invited to propose hosting the Flying Scot North Americans in July 2007. This event could bring 90 - 120 boats with double or triple handed crews, plus judges and class representatives. Recently, Jay Buhl asked me to chair a committee examining the feasibility of a proposal for this event. I welcome the input of every member on this question and write this article to spur discussion.

Without a doubt, these events sometimes stretch the capacity of our cooking, bathroom and launching facilities, tax the resources of our race management, and require careful policing to avoid disturbing our neighbors, or make members ask "whose club is this anyway?". Delicately balancing those issues is the task of each Event Chair who takes on these challenging assignments. Having chaired two of the large Junior events, I'll readily admit that I did not do some things as well as others and came away trying to think of ways to do them better next time. Nevertheless, on balance, I think an appropriate number and mix of these events is healthy for FBYC.

One misperception is that these events are subsidized financially by the membership. Actually, they are not. These events are carefully planned to break even or actually generate revenue for the club. In fact, there is nothing more remunerative to the club that the substantial "late fees" applied to registration for these events with the full blessing of the class association. Properly managed, the retail and food operations generate substantial revenue. For example, by delegating the design and production cost, and the inventory risk, to a national vendor, FBYC made almost \$2,000 on apparel sales at the Optimist Atlantic Coasts in 2004. The proposed 2007 Flying Scot North Americans has had registration fees of \$135 (timely) and \$180 (late). Proper event management with such fees should yield a positive revenue stream.

Any member who has competed in, or managed, these events will tell you that the larger number of boats and increased competition level make these events more fun and instructive. Nothing gets the adrenaline going like 50 or more boats on the line and dozens rounding the marks together. The skill levels and rules understanding of FBYC participants is improved. Competence and confidence of club race management is enhanced by the challenges of large events.

The prestige of the club in sailing circles is raised by these events. Visitors who might never have seen FBYC admire our facilities and hospitality and go home to tell others about it. In today's mobile society, today's listener may be tomorrow's FBYC member. Members of other local clubs who yearn for greater competition and race quality may be more likely to migrate to FBYC. The larger events get publicized more in national and class publication, spreading the word on our fantastic club.

As John Hubbard, Mike Massie, Mike Miller and I recently learned, the returns on hosting a nice regatta at FBYC include a regal reception at a distant club like Lake Norman. Folks we had gotten to know or hosted at FBYC met us in the evening, showed us where to park, made special arrangements for lodging, and numerous other special treatments. They, too, learned from our discussions of how we built our new clubhouse as they embark on a similar venture. In short, our sailing community was expanded by the experience.

These events inspire closer contact with the various class sailing organizations, whether they be the Flying Scot Sailing Association, the United States Optimist Dinghy Association, or others. The associations send representatives to monitor and judge our event and our race officials have the opportunity to operate under stricter scrutiny while improving their own performance and knowledge.

The experience of running these events tests our facilities and layout and shows us ways we can improve. The Optimist event demonstrated the utility of a separate temporary plywood ramp for hand launching from the new property. That ramp is now a permanent reality in our new grass ramp and our Junior and One design program are the better for it.

Recent events have demonstrated that these larger events bring significant returns for the economy of the community. Hundreds of sailors and their families stay for several days and spend money on lodging, food and various entertainments from Williamsburg to Busch Gardens. Appropriate articles in the local newspaper remind the community that we are making a contribution to the local economy.

These, in my view, are just some of the benefits of hosting invitational events. I welcome discussion or dissenting views as part of the process for considering the Flying Scot Event in 2007. ©




